Background:

The Dubai Business Delegation embarked on a significant journey facilitated by the IGTD EXIM CHAMBER OF COMMERCE, aiming to foster stronger economic ties between India and the United Arab Emirates (UAE). The delegation's mission was to capitalize on the robust trade relationship and explore new avenues for collaboration amidst evolving global dynamics.

Objective:

- Promote Bilateral Trade: The delegation aimed to enhance bilateral trade between India and the UAE, with a specific focus on key sectors such as agriculture, food, and spices.
- Identify Potential Partners: Through various engagements, the delegation sought to identify potential partners in both countries to facilitate trade and collaboration opportunities.
- Explore Market Dynamics: Delegates aimed to gain insights into market dynamics within the agriculture, food, and spice sectors in both India and the UAE, identifying key trends and opportunities.
- Facilitate Meaningful Collaborations: The overarching goal was to facilitate meaningful collaborations between businesses in India and the UAE, fostering mutually beneficial trade relationships and partnerships.

Overview of Delegation:

Comprising **24 Delegates from various sectors including agriculture, food, and spices, the delegation was organized by the IGTD EXIM CHAMBER OF COMMERCE.** The three-day visit, spanning from 19TH Feb to 22nd Feb, 2024,



included a meticulously planned itinerary to maximize engagement and exploration.

India-UAE Trade Relations:

India's trade relationship with UAE accelerated since the 1950s on the back of improved access to storage facilities and the oil boom, further propelled by emergence of Dubai as a key regional trading hub in 1990s. Post 2004, trade between two countries further gained momentum following free trade agreement (FTA) between India and Gulf countries.

As a result, India-UAE trade volume leaped from US\$180 million in 1970s to US\$75.44 billion in FY 2013. In subsequent years, India-UAE trade witnessed a slight slump in (US\$49.88 in FY 2018). In FY 2021, the Covid-19 pandemic led supply chain and trade disruptions also impacted India-UAE trade flows negatively, falling to about US\$42 billion. However, India-UAE bilateral trade bounced back by 68.4 percent year-on-year to reach US\$72.87 billion in FY 2022.

It must be noted that along with total trade, the trade gap has also widened between both countries in recent years, in favor of the UAE. In FY 2022, the India's trade deficit with UAE reached its maximum at US\$16.78 billion.



Day 1: Gulfood 2024 Exhibition Visit

On the first day of the delegation, our representatives embarked on a significant journey to the prestigious Gulfood 2024 exhibition in Dubai. This flagship event served as a beacon for the global food industry, providing an expansive platform to delve into the latest trends and innovations. Here, delegates immersed themselves in a world of culinary excellence, engaging with exhibitors, and navigating through a plethora of offerings.

In addition to exploring the vast array of exhibits, our delegates were honored with a special invitation from the Dubai Chamber of Commerce to attend a Breakfast Brief Meet.
